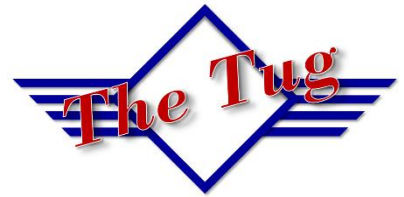


# THE PORT BYRON GREAT RIVER TUG FEST, INC.

## CRAFTER APPLICATION

AUGUST 11-13, 2016



The Port Byron Tug Fest Committee invites you to participate in our annual Great River Tug Fest. This year promises to be very exciting with fireworks on Friday night, the Great River Tug on Saturday afternoon, and live entertainment throughout the weekend.

Thank you in advance for reading everything both carefully and completely. This document will answer most of the questions that would otherwise come up at the last minute.

- **Craft Fair times:**
  - Friday August 12<sup>th</sup> 3PM till dusk (setup 11-2PM)
  - Saturday August 13<sup>th</sup> 9AM – 4PM (setup 8-9AM)
- **Location:** Main Street, Port Byron, IL
- **Cost:** \$50 per booth (electricity provided if needed for an additional \$20)

## REQUIREMENTS:

**APPLICATION:** The application on page 2 must be filled out completely and mailed to the address listed. The application deadline is **July 8th, 2016**.

**PICTURES OF CRAFT ITEMS AND/OR DISPLAY:** This is to ensure only approved items are sold. We do not allow flea market items, T-shirts, hats, or koozies to be sold by crafters.

**CHECK:** We must receive a check for the full amount. The booth fee is only \$50 (12'x12') and electricity is provided for an additional \$20. See below for more information.

**SALES TAX:** Sales Tax needs to be collected and paid (6.25% in Port Byron as of Feb 1<sup>st</sup>, 2011). Collection is the responsibility of the crafter.

**HOLD HARMLESS AGREEMENT:** Sign and return the enclosed Hold Harmless Agreement with your application.

## ADDITIONAL INFORMATION:

- Electricity is available at an additional cost of \$20 per booth. We have a 110 volt-20 amp service. It is the crafter's responsibility to be G.F.I. protected and to have matching plugs to our receptacles. Please be sure to bring plenty of your own cords.
- There will be minimal security provided overnight on Friday. Please plan accordingly.
- There will be no crafter parking behind booths. Parking passes will be provided for a set location close by.
- No refunds are given if the vendor chooses to depart earlier than the end time.
- If you tear down early, you will need permission from a Tug Fest committee member to bring your vehicle on to Main Street. This is for the safety of everyone.
- All crafters will be on a first come, first serve basis. Booths with electricity may be limited, so send in your application early.
- No flea market items, T-shirts, hats, or koozies. **Craft items only.**
